

Registration Info

The only group rate available is when registering with a problem solving court team. All teams will be coordinated by a designated individual within a court or jurisdiction. Teams will be organized by drug court type and seated together with a maximum capacity per table of 10. Additional attendees may be registered, but will not be seated with the team.

- Early Bird Registration is May 8 to August 17, 2018
 - ◇ \$150 per person for teams of four or more registered through the designated individual within a court or jurisdiction as noted above
 - ◇ \$175 early bird for single registrants
- Regular registration is August 18 to September 14, 2018
 - ◇ \$200 per person
 - ◇ No group rate available
- Late registration is September 15, 2018 – October 5, 2018: \$250 per person

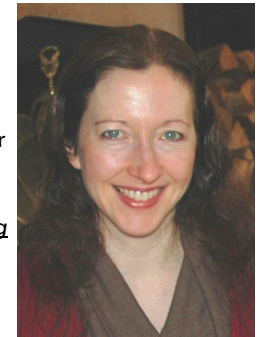

The morning session will begin with crowd favorite, Dr. David Mee-Lee. Doing Time or Doing Change? Discharge or Sanction? Collaborating for Accountable Treatment and Recovery will discuss how judges, court teams, treatment providers and all stakeholders can work together to move people beyond compliance with mandated treatment to engage participants in responsible, accountable change and recovery. Teams will: 1. Identify how to determine what intensity of treatment and level of care is needed for high risk, high need participants, 2. Discuss how to improve policies and procedures, sanctions and incentives, phases and programs to promote recovery in court participants, and 3. Apply motivational interviewing and stages of change work to determine when change is happening or when to terminate a participant. The afternoon session will bring all the pieces of the puzzle together in a fun and practical way as Shannon Carey, Co-President and Senior Research Associate at NPC Research and Practitioner Helen Harberts present Effectively Delivering Incentives & Sanctions in Treatment Court.
