About the Calendar and Certification

- The New Mexico Treatment Court Standards (Standards) were approved on January 22, 2021 by NM Supreme Court Order No. 21-8500002.
- The opening statement of the Preamble, on page two of the Standards, stipulates "All treatment court dockets
 operating under the auspices of a New Mexico court may only operate by order of the Supreme Court, and shall
 comply with all requests for data, processes established for recording and providing performance measures, and
 initiatives to measure alignment with standards, rules or guidelines, established by the Administrative Office of the
 Courts (AOC)."
- Section 8-17 of the *Standards* specifies that "Treatment courts shall develop and demonstrate material alignment with the NM Treatment Court Standards by participating in quality engagement initiatives coordinated through the AOC, including but not limited to, program certification, training, and other technical assistance."
- The New Mexico Treatment Court Certification Calendar will serve as the master list provided to the NM Supreme Court as the recommendation from the AOC to the Supreme Court for approved treatment courts.

- The schedule below is provided as an advance planning tool and will be updated at least semiannually. The official
